What: Launches 'COVID Emergency Loan Scheme' for Entrepreneurs supplying Oxygen, Medicines

When: published on 23rd April 2021

To ensure uninterrupted flow of vital medical supplies to fight the Covid-19 pandemic in the State, Haryana Government on Thursday announced "Haryana Covid Emergency Loan Scheme" for new and old entrepreneurs supplying medicines, oxygen and other medical facilities to Covid-19 patients.

For this, the State Government has set up a fund of Rs 500 crore.

The State Cabinet meeting held under the chairmanship of Chief Minister Manohar Lal Khattar gave approval to launch the scheme.

"Under the scheme, Haryana Government will help businessmen, presently working in the state, to increase their current production or to set up new units to meet various requirements to tackle Covid-19 pandemic. The scheme will come into effect from the date of notification and will remain in effect across the state," said Chief Minister Manohar Lal while talking to the mediapersons after the cabinet meeting. What: delivers first lot of light bullet proof vehicles to Indian Air Force

Hinduja flagship firm Ashok Leyland on Friday said it has delivered the first lot of light bulletproof vehicles to the Indian Air Force in collaboration with Lockheed Martin.

These modern vehicles were delivered on April 13. The light bulletproof vehicle (LBPV) is an adapted version of Lockheed Martin's CVNG (common vehicle next-gen), the company said in a regulatory filing.

It has been developed under the transfer of technology (TOT) from Lockheed Martin to Ashok Leyland. It is completely indigenised and developed in India, Ashok Leyland added.

LBPV has high off-road mobility in mud, sand, rocks, and shallow water. It can accommodate a crew of 6 with ample cargo space to carry substantial mission equipment.(Read more)

"The first core module of the new Russian orbital station is in the works," Rogozin said in a statement on messaging app Telegram.

He said Russia's Energia space corporation was aiming to have the module "ready for launch" in 2025 and released a video of Energia staff at work.(Read more)

India Ratings and Research on Friday revised down India's FY22 real GDP growth forecast to 10.1 per cent, from earlier projection of 10.4 per cent, citing the second wave of Covid-19 infections and slower pace of vaccination.

At a time when large parts of the country are experiencing tremendous pressure on medical infrastructure, the agency said it expects the second wave to start subsiding by mid-May.(Read more)

What: cancels licence of Maharashtra-based Bhagyodaya Friends Urban Co-operative Bank

When: published on 22nd April 2021

The Reserve Bank of India (RBI) on April 22 said it has cancelled the licence of Maharashtra-based Bhagyodaya Friends Urban Co-operative Bank Limited due to inadequate capital.

"Consequently, the bank ceases to carry on banking business, with effect from the close of business on April 22, 2021. The Commissioner for Cooperation and Registrar of Cooperative Societies, Maharashtra has also been requested to issue an order for winding up the bank and appoint a liquidator for the bank," the RBI said.

The Reserve Bank cancelled the licence of the bank as it does not have adequate capital and earning prospects, the RBI said. The bank has failed to comply with the requirements and the continuance of the bank is prejudicial to the interests of its depositors, the RBI said. (Read more)

What: issues USD 1.5 billion benchmark bond

On April 20, 2021, the New Development Bank (NDB) priced its 5-year USD 1.5 billion benchmark bond. This transaction is the third USD benchmark bond offering of the Bank in the international markets.

The net proceeds of the Bond will be used for financing sustainable development activities as well as COVID-19 Emergency Program Loans to the Bank's member countries. The NDB established the Emergency Assistance Facility in April 2020, to provide up to USD 10 billion in crisis-related assistance to its member countries, including USD 5 billion for financing healthcare and social safety-related expenditures, as well as USD 5 billion for supporting economic recovery efforts.

This transaction was met with significant support from the global investor community. The high-quality order book highlights the recognition of NDB's mandate and its growing stature in the USD market. The distribution of investors of the final book was as follows, by geography: Asia - 36%, EMEA - 60%, Americas - 4% and by investor type: Central Banks/Official Institutions - 78%, Banks - 16%, Asset Managers - 4%, Private Banks - 1%, Others - 1%. The book was oversubscribed with the order book in excess of USD 1.975 billion.(Read more)

What: will overtake China's by 2035: Central Bank of China

China's demographic transition owing particularly to its stricter birth policies has grappled it with the problem of ageing population and dwindling work-force. A report released by the People's Bank of China (PBOC), China's central bank, said that China should immediately liberalise its birth policies to tackle the problems of an ageing population and plan to compete economically with a demographically young India and an immigration-friendly US.

In a detailed section on India, the report said the gap between the two countries is narrowing. As two big countries in Asia, China's economic growth has been faster than India's for a long time but in recent years, China's demographic dividend fading, India's economic growth has tended to approach China's, the report said. In a rare frank assessment, it added that China's ageing population and the declining birth rate will become more serious in 10 years while India's demographic structure will be further optimised. World Day for Laboratory Animals – April 24th – commemorates the suffering of animals in laboratories. Founded in 1979 by ADI's campaign partner in the UK, National Anti-Vivisection Society, World Day for Laboratory Animals has been a focal point for educating the public and

legislators about animal tests and the alternatives for 40 years.

Founded in 1875, the National Anti-Vivisection Society (NAVS) was the world's first organisation campaigning against animal experiments, and established the Lord Dowding Fund for Humane Research (LDF) in 1973 to support and fund advanced non-animal methods of scientific and medical

research.

Founded in 1990, Animal Defenders International (ADI) funds and promotes advanced scientific methods to replace the use of animals in research, the LDF transferred to its charitable foundation

in 2017.(Read more)

National Panchayati Raj Day 2021: April 24 has been recognised as National Panchayati Raj Day. The annual celebration is done to commemorate the day on which the 73rd Constitutional Amendment was passed in 1992. The act came into effect on April 24, 1993. Former Prime Minister Manmohan Singh had declared the first National Panchayati Raj Day on 24 April in the year 2010. National

Panchayati Raj Day is celebrated to mark the inception of decentralised power.

A committee was formed in 1957 to focus on the evolution of Panchayati Raj in the country. The chairman of the committee was Balwantrai Mehta. The committee in its report recommended a decentralised three-layered Panchayati Raj system – Gram Panchayat at the Village level, Panchayat Samiti at the Block level and Zila Parishad at the District level.
