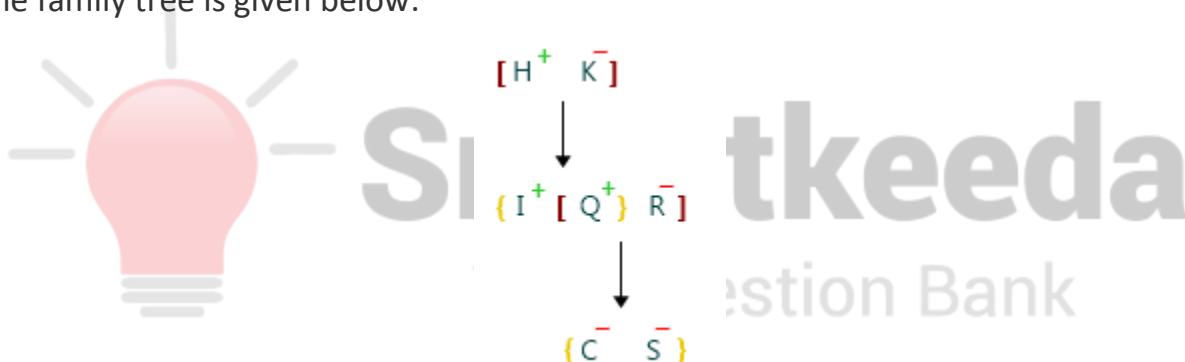
Explanations:

The family tree is given below:



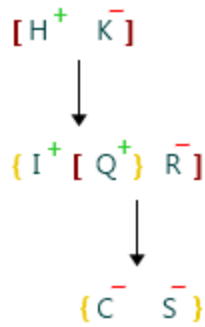
It's evident from the 'height sequence' that 4 persons are taller than K. Therefore, option 'E' is the correct answer.

The family tree is given below:



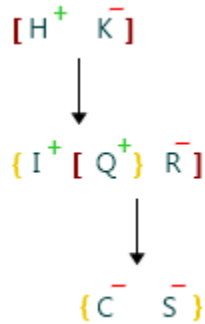
It's evident from the 'family tree' that K is mother of I.

It's evident from the 'height sequence' that C is shortest in all of them.

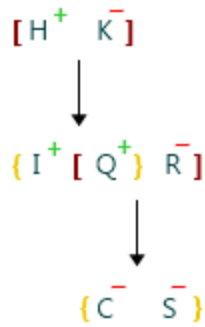
Therefore, option 'A' is the correct answer.

The family tree is given below:



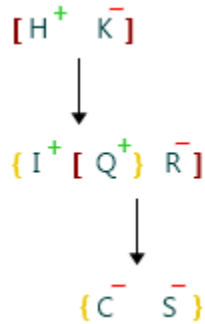
It's evident from the 'family tree' that S is niece of I.
