
### Common Explanation: (Q. 7 to 9)

#### **Reference:**

Roop is father of Geet and Meet is mother of Roop. Kanu, the husband of Meet is the grandfather of Soni. Kanu has only two children, both of opposite gender.

After using the above hints we can create a following blood chart:




At this point Soni can be the child of either Roop or Roop's sister. So, we will use this information later.

### Answers.

**7.** Following the final solution we can say that relationship between Geet – Kanu cannot be determined. Hence, the correct answer is option C.

8. Following the final solution we can say that if Sona is the sister in law of Tanu then Tony is the aunt of Geet.

Hence, the correct answer is option B.

- 9. Following the final solution we can say that Pret can be either Aunt or Uncle of Tanu. Hence, the correct answer is option E.
- **10.** Person's father = Only son of woman's daughter's grandfather's husband's = Woman's husband. Hence, option B is correct.
