Who: World health, IP, trade bodies

What: launch platform to tackle COVID-19 pandemic

When: published on 25th June 2021

Heads of the global health, intellectual property and trade bodies have announced a joint platform to help countries plug the gaps in accessing Covid-19 vaccines, treatments and technologies.

World Health Organization's Tedros Ghebreyesus, World Intellectual Property Organization's Daren Tang and World Trade Organization's Ngozi Okonjo-Iweala said they want to map out further collaboration to tackle the pandemic. In a joint statement, they said they will implement a joint platform for tripartite technical assistance to countries relating to their needs for Covid-19 medical technologies. They further said countries would be able to access expertise in places where the three fields cross over in battling the pandemic.

The platform will provide "a one-stop shop that will make available the full range of expertise on access, intellectual property and trade matters provided by our organisations, and other partners, in a coordinated way. The statement said, it would support countries in assessing and prioritising their unmet needs for Covid-19 vaccines, medicines and other related technologies. It would also help them make full use of all available options to access such tools, including through coordinating with other countries going through similar challenges, it added.

What: among top 5 tech centres in Asia Pacific, says report

When: published on 25th June 2021

Bengaluru has emerged as the top five technology centres in Asia Pacific region, according to a report by Colliers. Hyderabad ranked in the top 10 list in the report titled 'Growth Engines of Innovation: How Asia Pacific Technology Hubs are Reshaping Regional Real Estate'.



The study ranks the most attractive technology submarkets within major APAC (Asia-Pacific) cities, which should serve as a navigation tool for technology groups, as they plan their expansion. Beijing bagged the top spot in the list followed by Shanghai, Bengaluru, Shenzhen, and Singapore.

Among established technology submarkets in major APAC cities, the report highlights Shangdi in Beijing. Among upcoming submarkets, it further highlights Yangpu in Shanghai, Hitec City (Suburban Business District) in Hyderabad as well as Sydney's CBD South, Whitefield and North Bengaluru in Bengaluru.

What: is world's most expensive city for foreign workers, Mumbai drops 18 places, as per the Report

When: published on 22nd June 2021

Turkmenistan's capital city Ashgabat has become the world's most expensive city for foreign workers, according to this year's Mercer Cost of Living Survey. The annual report has ranked 209 cities across five continents by measuring the comparative cost of more than 200 items, including housing, transportation, food, clothing, household goods, and entertainment. The survey used New York City, ranked 14 on the list, as the base city and currency movements were measured against the US dollar.

List of top 10 expensive cities mostly features global financial hubs like Hong Kong, which was the priciest last year, Tokyo, Shanghai, Zurich and Singapore. Mercer has cited Turkmenistan's ongoing financial crisis as the reason for Ashgabat's high cost of living. Another outlier on the list is third-ranked Beirut which climbed 42 positions up the ranking due to a severe and extensive economic depression owing to several crises, including coronavirus disease (Covid-19) and the Port of Beirut explosion in 2020.

An Indian Navy warship carried out a military exercise with a South Korean vessel in the East China Sea on Monday amid China's growing assertiveness in the region, officials said.



"Indian Navy's indigenous ASW Corvette INS Kiltan deployed in the Far East undertook Navy Partnership Exercise in East China Sea with Republic of Korea Navy Ship--ROKS Gyeongnam, a Daeguclass frigate, on June 28," a spokesperson of the Indian Navy said.

The Navy partnership exercise is aimed at enhancing interoperability and facilitating exchange of best practices with partner navies in the maritime domain.

Haryana Chief Minister Manohar Lal Khattar on Wednesday launched 'Jan Sahayak Aapka Sahayak' mobile app for Government to Citizen (G2C) and Business to Citizen (B2C) services. He also announced a scheme for providing ownership rights to Urban Local Bodies (ULBs) property holders.

Addressing a press conference on Wednesday, the CM said that the app is a single platform for availing government services, emergency helplines and other services which included information on tenders and jobs, and payment of bills.

The helplines included 112 for emergency calls, 100 for police, 108 for ambulances, 101 for fire, 104 for health, 1091 for women, 1098 for children and 1075 for Covid.

What: unveils 'Hausla' scheme for J-K's women entrepreneurs

When: published on 30th June 2021

Lieutenant Governor of Jammu and Kashmir Manoj Sinha launched a scheme "Hausla" for women entrepreneurs of the Union Territory (UT) which aims at promoting their potential and enable a wider reach of their products and services.

The main objective of the scheme is to build a comprehensive programme for women entrepreneurs of the region which can serve as a guide for achieving success in their business.

"This programme will definitely help the women entrepreneurs. Where there is a will, there is a way. We had decided to provide financial assistance to 10,000 people when we started the 'Back to Village' programme, but we managed to provide the aid to more than 19,000 of them. Out of which, 4,500



were girls. This year, we have set a target of providing financial aid to 50,000 Kashmiri youth in Jammu and Kashmir," Jammu and Kashmir LG Manoj Sinha said.

Who: Goods and Services Tax (GST) Day 2021

What: was observed on July 1

India marks the fourth anniversary of the Goods and Services Tax (GST) on Thursday, July 1, 2021. The date 1st July has been designated by the Central Government as 'GST Day', which is celebrated every year to mark the roll-out of the historic tax reform. Finance Minister Nirmala Sitharaman on Wednesday said that on GST Day this year, the Union Finance Ministry will issue appreciation letters to over 54,000 GST payers for timely filing of returns and a cash payment of tax.

The Goods and Services Tax (GST) is an indirect, multi-level, comprehensive tax levied on the supply of goods and services in India. On roll-out, GST subsumed almost all other domestic indirect taxes in the country (petroleum, alcoholic beverages, and stamp duty being the major exceptions) under one head, and is perhaps the biggest tax reform in the history of independent India. The GST is levied at every stage of the production process but is collected from the point of consumption, refunding all parties eventually other than the end consumer.

On completing 4 years of GST, Finance Minister Nirmala Sitharaman mentioned the journey of GST. Finance Minister stated the success of GST and measures taken to give relief to taxpayers, especially at the time of Covid.

Journalist Sundeep Mishra's book titled 'Fiercely Female: The Dutee Chand Story' chronicles Chand's journey with a detailed narrative of the gender-identity controversy that made her an iconic figure in Indian sport.

Published by Westland Books, the book will be released on 22 June on 'SoftCover' —ThePrint's evenue to launch select non-fiction books.

Coming from a small village in Odisha, Dutee Chand went on to hold the national record in the women's 100 metres and is only the fifth Indian to participate in the women's 100 metres at the Olympics when she qualified for the 2016 Rio Games.

However, controversy regarding her gender identity abruptly interrupted her dreams as she was dropped from the 2014 Commonwealth Games on the charge that she was ineligible to compete as a female athlete.

He used advanced technology, made 'Sudharma' available online and launched the epaper. The print edition of 'Sudharma' has nearly 4,000 readers from various Sanskrit universities and institutions across the country. However, the digital edition has more readers. He had once said in a programme that the newspaper has readers from Kashmir to Kanyakumari.

The tournament was originally scheduled for Australia last year, but it was delayed to this year due to the pandemic and given to India. But India's ability to host was put in doubt in May when the Indian Premier League was postponed after several players tested positive for the coronavirus.

The 12-year-old from New Jersey in United States became a GM from International Master, having crossed the required 2500 Elo rating barrier, chess.com website said.

Mishra broke GM Sergey Karjakin's record that has stood for 19 years.

What: picks up minority stake in Mobikwik for \$20 million

When: published on 27th June 2021

The UAE's sovereign wealth fund Abu Dhabi Investment Authority has picked up a minority stake in the IPO-bound digital payments player Mobikwik for nearly \$20 million (about Rs 150 crore), valuing it at USD 700 million, the company has said. The company was in bad press in March after alleged massive data theft, following which the Reserve Bank of India (RBI) had ordered a forensic audit on the Gurugram-based company set up in 2009. Personal data of its about 10 million customers were allegedly stolen by hackers.

The latest round of funding of \$20 million from the Abu Dhabi Investment Authority values the company at \$700 million (nearly Rs 5,193 crore), according to a Registrar of Companies (RoC) filing by Mobikwik. Since March 2021, it has raised over Rs 235 crore.

The Competition Commission of India (CCI) approves merger of Tech Data Corporation (Tech Data) with SYNNEX Corporation (SYNNEX) under Section 31(1) of the Competition Act, 2002, yesterday.

The Proposed Combination is a merger within the meaning of Section 5(c) of the Competition Act, 2002. It will be effected through the following steps:

Merger of Sub I with and into Tiger Parent, with Tiger Parent being the surviving entity;

Merger of Tiger Parent with and into Sub II, with Sub II being the surviving entity and remaining as a direct wholly owned subsidiary of SYNNEX; and

Upon steps (i) and (ii) of the transaction coming into effect, and in consideration of the shares of common stock of Tiger Parent held by Tiger Holdings, SYNNEX will issue approximately 45% shares of its common stock (carrying proportionate voting rights) to Tiger Holdings.

Of the USD 500 million commitment, USD 112.50 million will be financed by its concessionary lending arm International Development Association and USD 387.50 million will be a loan from International Bank for Reconstruction and Development (IBRD).
