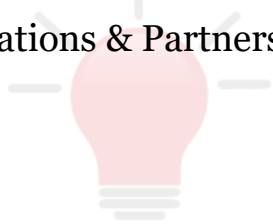

The two-lane highway, NH-913, will aim to stop infiltration in the border areas and will be built by the Ministry of Road Transport & Highways. 410. On December 14, National Technical Advisory Group on Immunization (NTAGI) announced that India will soon immunize girls aged 9-14 from HPV under a national vaccination program. The nationwide drive will begin by mid-May 2023. The quadrivalent vaccine called Cervavac which will be used for the nationwide vaccination drive of adolescent girls is developed by the Serum Institute of India (SII) and will offer protection against four strains of HPV - 16, 18, 6, and 11. Following Sikkim’s 2016 model, girls in the age group of 9-14 years will be given the HPV vaccine in campaign mode first. The approval of SII’s vaccine was granted by the drug regulator (DGCI) in July 2022. [{Read more}](#)

Joint annual training exercise with the Kazakhstan Army was instituted in 2016 as Exercise Prabal Dostyk, which was later upgraded to a company level exercise and renamed as Ex Kazind in 2018. This joint exercise will enable the two armies to train, plan and execute a series of combined tactical drills for neutralising of likely threats that may be encountered in UN peace keeping operations. “Exercise KAZIND” will enhance the level of defence cooperation between Indian Army and Kazakhstan Army which will further foster the bilateral relations between the two nations. 420. The 16th Edition of Indo-Nepal joint training Exercise “SURYA KIRAN-XVI” between India and Nepal was conducted at Nepal Army Battle School, Saljhandi (Nepal), from 16 - 29 December 2022. Exercise “SURYA KIRAN” is conducted annually between India and Nepal with the aim to enhance interoperability in jungle warfare & counter terrorism operations in mountainous terrain and HADR under UN mandate. 421. INS Mormugao (D67), second warship of the P15B class of stealth, guided-missile destroyers of the Indian Navy, was commissioned on December 18 at Naval Dockyard, Mumbai, in the presence of Rajnath Singh, Defence Minister, the Chief Guest for the function. The commissioning ceremony marks the formal induction of the ship into the Indian Navy. ‘Y 12705’ (Mormugao) is the second ship of Project 15B stealth guided missile destroyers, built at Mazagon Dock Shipbuilders Ltd (MDL). Designed by Indian Navy’s in-house Warship Design Bureau, and built by Mazagon Dock Shipbuilders Ltd, Mumbai, the four ships of the Project are christened after major cities from all four corners of the country, viz. Visakhapatnam, Mormugao, Imphal and Surat. [{Read more}](#)

422. The United States, Canada, and Mexico are all set to jointly host the prestigious “FIFA World Cup 2026”. Canada will be hosting the prestigious FIFA World Cup for the very first time in comparison to the United States and Mexico which will be hosting it for the second and third time respectively. FIFA has released a list of 16 cities from these 3 countries which will be hosting the matches. The three countries won the bid to host the tournament in 2018 and named it “United 2026”. These North American nations will be hosting the tournament in a completely new and expanded format by giving platforms to 48 teams/nations. The natural format of FIFA had 32 teams drawn into 8 groups of 4 countries. [{Read more}](#)

423. On December 14, Indian swimmer Chahat Arora set a national record in the women’s 100m breaststroke at the 16th edition of the “FINA World Swimming Championships 2022” in Melbourne, Australia. Chahat Arora completed the 100m breaststroke race in 1:13.13s at the Melbourne Sports and Aquatic Centre’s 25m short course pool. Moreover, Chahat also set a new national record in the women’s 50m breaststroke at the same tournament on December 17. She clocked 32.91s to top heat 2 at the Melbourne Sports and Aquatic Centre’s 25m short course pool and bettered her own previous record of 32.94s. [{Read more}](#)

424. On December 15, India successfully carried out night trials of Agni-5 nuclear-capable ballistic missile. The test was carried out from APJ Abdul Kalam Island, Odisha to validate new technologies and equipment on the missile. The trial has proved the capability to enhance the range of the Agni-5 missile if required. The missile, which uses a three-stage solid-fuelled engine, is capable of striking targets at ranges up to 5,000 kilometres with a very high degree of accuracy. [{Read more}](#)

The satellite will shoot radar pulses at Earth, with the signals bouncing back to be received by a pair of antennas, one on each end of a 33-foot (10-meter) boom. 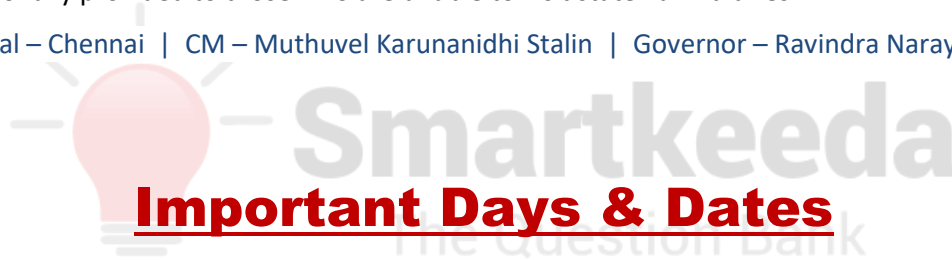
