452. On January 24, the occasion of National Girl Child Day and Cervical Cancer Awareness Month (January), the Serum Institute of India (SII) launched the first indigenously developed human papillomavirus vaccine (HPV), "CERVAVAC", against the cervical cancer in women. It was launched by the hands of Home Minister Amit Shah. The vaccine has jointly been created by the SII and the Department of Biotechnology (DBT). Cervical cancer is the fourth most common cancer in women after breast, lung, and colorectal cancer, with the country accounting for nearly one-fourth of the world's cervical cancer deaths. {Read more}

453. On January 21, Tamil Nadu government will set up a ₹6.30 Crore 'Turtle Conservation and Rehabilitation Centre' at the Guindy National Park in Chennai to boost its conservation efforts. Turtles are facing severe threats due to increasing biotic pressure. A rescue and treatment centre will be set up for injured turtles to rehabilitate them back to the sea after recovery. {Read more}

The GST on various products and services are based on their classification in the Harmonised System of Nomenclature (HSN) codes. 455. On January 23, the Indian Government has launched "U-WIN" to digitise India's universal immunisation programme. The U-WIN is going to be the single source of information for immunisation services, updating vaccination status, delivery outcome, planning of RI sessions and reports like antigen-wise coverage, etc. The programme to digitise India's Universal Immunisation Programme (UIP) has been launched in a pilot mode in two districts of each state and Union Territory. The platform replicates Co-WIN which has served as the digital backbone for India's COVID-19 vaccination programme. {Read more}

456. On January 25, Germany agreed to provide Ukraine with 'Leopard 2' battle tanks. The Leopard 2 is a 3rd-generation German main battle tank. Developed by Krauss-Maffei in the 1970s, the tank entered service in 1979 and replaced the earlier Leopard 1 as the main battle tank of the West German army. {Read more}

With this announcement, India has become the first creditor nation to extend assurance towards restructuring the debt of Sri Lanka. Moreover, Sri Lanka thanked India for the generous support of a USD 3.9 billion credit line in 2022. {Read more}

458. On January 24, JPMorgan Chase & Co. has received approval from the RBI to appoint Prabdev D. Singh as the CEO of JP Morgan Chase Bank India for a period of 3 years. Singh had been JPMorgan's interim CEO since November 2022, replacing Madhav Kalyan. JPMorgan, which started commercial banking operations in India about 15 years ago, has 4 commercial bank branches in the country. {Read more}

459. On January 23, as part of an initiative to develop bond markets, the SEBI organised an outreach programme on municipal bonds and municipal finance. The two-day event saw participants representing all stakeholders including the ministry of housing and urban affairs, municipal corporations, stock exchanges, credit rating agencies, merchant bankers, debenture trustees, lawyers, NGOs and institutional investors. To assist municipal debt issuers and other stakeholders in the municipal debt market, SEBI Whole-Time Member Ashwani Bhatia launched an 'Information Database' including a repository of information pertaining to municipal bonds on its website. The information database can also be accessed by way of a QR Code. SEBI, in 2015, introduced a regulatory framework for the issue, listing and trading of municipal debt securities; the same was further reviewed by SEBI in 2019. {Read more}

461. On January 26, National Asset Reconstruction Company Ltd (NARCL) has acquired its first stressed asset, Jaypee Infratech, from lenders. It acquired their exposure aggregating about Rs 9,200 Crore at a 55% haircut. IDBI Bank, with an exposure of ₹3,750 crore, received ₹253 crore in cash and ₹1,434.5 crore in the form of security receipts. NARCL, which was set up by banks last year, is aggregating and consolidating select stressed assets (above ₹500 crore each) in the financial system for their subsequent resolution. Along with NARCL, India Debt Resolution Company Ltd (IDRCL), has been floated for resolving these stressed assets. {Read more}

462. On January 23, Housing Development Finance Corporation (HDFC) Ltd plans to raise at least Rs 30 billion (\$370.5 million) through the sale of bonds maturing in 10 years. The housing finance company has invited coupon and commitment bids from bankers and investors. The issue will also have a greenshoe option to retain an additional Rs 20 billion. The bonds are rated AAA by CRISIL and will have a put option at the end of the third year. {Read more}

On January 24, the Reserve Bank of India (RBI) has extended the deadline for banks to finish the process of renewing agreements for existing Safe Deposit Locker holders (customers) in a phased manner by December 31, 2023 (from January 1, 2023 earlier). By April 30, 2023, banks are advised to inform all their clients of the amended requirements. By June 30 and September 30, 2023, banks should make sure that at least 50% and 75% of their current customers have signed the revised agreements. {Read more}

Under the Liberalised Remittance Scheme, Indian residents, including minors, are allowed to freely remit up to USD 2,50,000 per financial year (April-March) for any permissible current or capital account transaction or a combination of both. The scheme was introduced in 2004. {Read more}

As of January 2023, Agriculture Infrastructure Fund (AIF), which was launched in July 2020, has mobilised over Rs 30,000 Crore for taking up projects related to creation of post-harvest management facilities. The AIF is a financing facility for creation of post-harvest management infrastructure and community farm assets. Under this scheme, Rs 1 Lakh Crore is to be disbursed by financial year 2025-26 and the interest subvention and credit guarantee assistance will be given till the year 2032-33. Within two-and-a-half years of the implementation of the AIF, the scheme has mobilised more than Rs 30,000 crore with a sanctioned amount of Rs 15,000 Crore under AIF. The AIF is providing financial support to the farmers, agrientrepreneurs, farmer groups like Farmer Producer Organisations (FPOs), Self Help Groups (SHGs) and Joint Liability Groups. {Read more}

On January 21, as tensions between India and China along the Line of Actual Control in Arunachal Pradesh have recently risen, the Indian Air Force (IAF) will conduct a massive exercise named "Poorvi Aakash" covering the Northeastern region in February to assess its combat readiness. The annual Command-level exercise will be conducted by Eastern Air Command. The exercise is expected to involve every frontline air base in the Northeast as well as some significant Advanced Landing Grounds (ALGs). {Read more}

On January 21, in an important step that will significantly enhance the endurance of the Scorpene-class conventional submarines of the Indian Navy, the Defence Research and Development Organisation (DRDO) and Naval Group of France have signed an agreement to fit the indigenous fuel cell-based Air Independent Propulsion (AIP) system on INS Kalvari. The AIP has been developed by DRDO's Naval Materials Research Laboratory (NMRL). Six Scorpene submarines are being built under Project-75 by the Mazagon Dock Shipbuilders Limited (MDL) under technology transfer from Naval Group of France under a \$3.75 billion deal signed in October 2005. {Read more}

They defeated Denmark's Viktor Axelsen & Japan's Akane Yamaguchi, respectively. Liang Wei Keng and Wang Chang came out as the winners in men's doubles. Japan's Yuta Watanabe and Arisa Higashino won the mixed doubles title, while Nami Matsuyama and Chiharu Shida, also from Japan, claimed the women's doubles crown. {Read more}

472. On January 23, 'Ironman of India' Sabir Ali, who won the decathlon gold at the '1981 Asian Athletics Championships' in Tokyo, passed away in New Delhi following a cardiac arrest. He was 67. Ali, who retired from Railways, won the title in the Japanese capital with a tally of 7,253 points beating Japan's Nobuya Saito (7,078) and China's Zu Qilin (7,074). He also won two silver medals at the South Asian Federation Games held in Kathmandu and Dhaka. Ali won 8 consecutive Open National titles in the gruelling event between 1979 and 1985. The decathlon is a combined event in athletics consisting of ten track and field events. {Read more}

The court also allowed release of money by the Centre to the National Rifle Association of India (NRAI) to be used for the event. 

Subsequently, the satellite will be shipped to South America. The spacecraft will make a series of flybys of Jupiter's planet-sized moons - Callisto, Ganymede and Europa. The objective is to ascertain whether Callisto, Ganymede and Europa are habitable or not. Juice satellite will undertake a journey of 6.6 billion kilometre that will last 8.5 years. It will reach Jupiter in July, 2031. {Read more}
