On January 26, Govind Mohan, the Secretary of the Ministry of Culture, announced to hand over around 1,000 monuments under the control of the Archaeological Survey of India (ASI) to the private sector for their upkeep under the 'Monument Mitra Scheme'. Corporate entities will take over these monuments as part of their Corporate Social Responsibility (CSR). The government has set the target to hand over 500 sites under the revamped 'Monument Mitra Scheme' by the end of Azadi ka Amrit Mahotsav on 15 August, 2023. {Read more}

Broadcasters in India will have to set aside at least 30 minutes of air time daily for public service programming (PSB) of national importance and social relevance from March 1, 2023, according to the "Guidelines for Uplinking and Downlinking of Television Channels in India, 2022" released by the Ministry of Information & Broadcasting. All broadcasters will have to submit a report on the government's Broadcast Seva Portal by the 7th of the following month. The broadcaster shall keep the record of the content telecast for a period of 90 days. {Read more}

604. On January 31, Maharashtra government officially adopted 'Jai Jai Maharashtra Majha' as the State song. The decision to adopt the song was taken at a Cabinet meeting chaired by CM Eknath Shinde. The song was set to be adopted on February 19, the birth anniversary of the 17th century Maratha warrior-king Chhatrapati Shivaji. The song, translated into English as 'Glory to Maharashtra', was composed/written by Marathi poet Raja Badhe and sung by renowned folk artiste Krishnarao Ganpatrao Sable, affectionately known as 'Shahir' Sable. {Read more}

605. On January 31, Ministry of Law and Justice constituted a working committee for the drafting of rules and standards for mediation in India under the chairmanship of former Law Secretary P. K. Malhotra. The committee would also provide a method for the active dissemination of the benefits of the provisions of the Mediation Bill/Act and give wide publicity to the said provisions amongst the stakeholders and the citizens. The Bill also provides for the establishment of the Mediation Council of India. The Mediation Bill, 2021 was introduced in the Rajya Sabha on December 20, 2022. {Read more}

Jeevan Vidya Shivir is a co-existence workshop based on the Coexistential philosophy of A Nagraj. This Shivir was held to help teachers in building their capacity to find those gaps present in the education system and fill them. {Read more}

Under this Alliance, one of the key priorities has been to accelerate women in STEM education and the workforce. Courses will be offered here in forensic sciences to boost capability in gathering scientific evidence from crime scenes in Karnataka. {Read more}

Cultural programmes were also held. The rally is the culmination of NCC Republic Day Camp (RDC) and is held on January 28 every year at Delhi's Cariappa Parade Ground. A total of 196 officers and cadets from 19 foreign countries were invited to be a part of the celebrations. During the event, PM Modi also released a special day cover and a commemorative and specially minted coin of ₹75 denomination, marking the 75 successful years of the NCC. {Read more}

610. Ministry of Science and Technology published the 'National Geospatial Policy, 2022'. The policy seeks to establish a high-resolution topographical survey and mapping and a high-accuracy digital elevation model for the entire country by 2030, in addition to developing geospatial infrastructures, skills and knowledge, standards, and enterprises. The policy describes the creation of 14 National Fundamental Sectoral Geospatial Data Themes. India's geospatial economy is expected to surpass Rs. 63,000 crores by 2025, with the growth of 12.8%. The initiative would create a 'National Geospatial Data Framework' and make data affordably available to enterprises and the general public. By 2025, the government plans to implement a legal framework that supports geospatial sector liberalisation and data democratisation for improved commercialisation with value-added services. The government intends to create an Integrated Data and Information Framework (IDIF) through which a Geospatial Knowledge Infrastructure (GKI) will be built by 2030. {Read more}

611. The Justice G. Rohini-led commission for the sub-categorisation of Other Backward Classes (OBCs) has been given 6-month another extension in its tenure by the President, according to a gazette notification issued by the Union Ministry of Social Justice and Empowerment on January 29, 2023. This is the 14th extension in tenure. The commission, formed in October 2017, was initially given 12 weeks to finish the task of sub-categorizing the nearly 3,000 castes within the OBC umbrella and recommend division of the 27% OBC quota among them equitably. The commission decided to divide all OBC communities into 4 broad categories. {Read more}

On January 30, Infibeam Avenues Ltd's flagship brand, CCAvenue, became India's First payment gateway player to process Central Bank Digital Currency (CBDC) or Digital Rupee transactions for online retail merchants. It is an industry first where CCAvenue has facilitated CBDC online transactions with an aim to strengthen India's digital payments ecosystem further. The aim of the Indian government and the RBI in launching the Digital Rupee is to reduce the ₹32 Lakh Crore of cash in circulation. The RBI has identified 8 banks for phase-wised participation in the retail pilot project for CBDC. The first phase includes 4 banks, namely the SBI, ICICI Bank, Yes Bank and IDFC First Bank. {Read more}

613. On January 31, IDFC FIRST Bank has partnered with ToneTag, a global proximity and voice tech solution provider, to enable acceptance of digital rupee at merchant outlets. This follows a pilot launch of Central Bank Digital Currency (CBDC) for retail users by the RBI. In December 2022, the RBI launched a pilot for retail digital rupee (e₹-R) with 4 banks in 4 cities, including IDFC FIRST Bank, a month after testing the wholesale CBDC. The CBDC will be mainly used for retail payments just like "cash". It will be a digital rupee (e₹-R) signifying legal tender in the form of digital token and issued in the same denominations as paper currency and coins and will be distributed through intermediaries, i.e., banks. As per RBI, users will be able to transact with e ₹-R through a digital wallet offered by the participating banks and stored on mobile phones or hardware wallets to facilitate person-to-person (P2P) and person-to-merchant (P2M) transactions. As in the case of cash, it will not earn any interest and can be converted to other forms of money, like deposits with banks. {Read more}

614. On January 31, Reserve Bank of India appointed V. The appointment followed the resignation of Farokh N. Subedar from the Advisory Committee. The Advisory Committee now comprises Venkat Nageshwar Chalasani, former deputy MD at State Bank of India, TT Srinivasaraghavan, former MD of Sundaram Finance, and V Ramachandra, former Chief General Manager at Canara Bank. {Read more}

615. On January 27, Edelweiss Asset Management (EAM) Limited launched 'Edelweiss CRISIL IBX 50:50 Gilt Plus SDL Short Duration Index Fund', India's first passive short-duration index fund. The new fund offer was open for subscription from January 27 to February 10. Edelweiss CRISIL IBX 50:50 Gilt Plus SDL Short Duration Index Fund will replicate CRISIL IBX 50:50 Gilt Plus SDL Short Duration Index by investing in a diversified portfolio of Indian Government Bonds and SDLs, subject to tracking errors. Edelweiss CRISIL IBX 50:50 Gilt Plus SDL Short Duration Index Fund will invest in 50% Indian Government Bonds (IGBs) and 50% State Development Loans (SDLs). The G-Sec portion will be constructed by selecting most liquid Government Bonds with a minimum outstanding of Rs 10,000 Cr falling in duration buckets starting from 1 year to 5 years. The lower cost will add up in the returns. This cost-effective index fund can be an ideal option for investors looking to include fixed income in their portfolio as a component of their asset allocation strategy. {Read more}

616. On January 24, SBM Bank (India) raised ₹99 Cr from Life Insurance Corporation of India (LIC) through the issue of tier-II bonds. This is the second tranche of tier-II bond issues by the bank, which had earlier raised ₹125 Cr in its maiden such issue in April 2022 at a rate of 9.75%. With this fresh round, SBM Bank India has now cumulatively raised ₹224 Cr via tier-II bonds. SBM Bank India is the wholly-owned subsidiary of Mauritius-based SBM Group. The bank has a network of 12 branches across the country, including the recently opened branch in Kolkata. {Read more}

617. In January 2023, the Reserve Bank of India (RBI) issued its list of Domestic Systemically Important Banks (D-SIBs) of 2021 based on the data from March 31, 2022. In line with the 2020 list of D-SIBs, SBI, ICICI Bank, and HDFC Bank are still categorized as Domestic Systemically Important Banks (D-SIBs). The additional Common Equity Tier 1 (CET1) requirement for DSIBs was phased in from April 1, 2016 and became fully effective from April 1, 2019. On July 22, 2014, the Reserve Bank published the Framework for handling D-SIBs. D-SIBs are also known as 'too-big-to fail' banks. They are interconnected entities, whose failure can impact the whole of the financial system and create instability. ICICI Bank & HDFC Bank will be in the 1st bucket with an Additional CET-1 requirement as a percentage of RWAs of 0.20%. While SBI will be in the 3rd bucket with an Additional Common Equity Tier (CET)- 1 requirement as a percentage of Risk Weighted Assets (RWAs) of 0.60%. {Read more}

- RBI issued its list of Domestic Systemically Important Banks (D-SIBs) for 2021 (based on data from March 31, 2022)
- At present, D-SIBs include 3 banks: SBI, ICICI Bank, HDFC Bank (aka 'too-big-to fail' banks)

618. The gross non-performing asset (GNPA) ratio of Scheduled Commercial Banks (SCBs) fell to a 7-year low of 5% in in September 2022 (Q2 FY23), as per the 26th Financial Stability Report (FSR) released by the RBI in January 2023. The net nonperforming assets (NNPA) dropped to 10-year low of 1.3% in September 2022. India's Current Account Deficit (CAD) widened to 4.4% of GDP in Q2 FY23, the highest since the June quarter of 2013. India's foreign exchange reserves on BoP basis recorded a deficit of USD 30.4 billion in Q2 FY23, compared to a USD 31.2 billion surplus in the Q2 FY22. The system-level Capital to Risk Weighted Assets Ratio (CRAR) in September 2023, under baseline, medium and severe stress scenarios, is projected at 14.9%, 14% and 13.1%, respectively. {Read more}

In January 2023, Department of Economic Affairs, under Ministry of Finance, hiked the interest rate on various Small Savings Schemes for Q4 of the current FY 2022-23 (January 1, 2023 - March 31, 2023). The interest rate of 5-year National Saving Certificate (NSC) has been increased to 7% from 6.8%. The interest rate on the Senior Citizen Saving Scheme (SCSS) increased to 8% from 7.6%. The Monthly Income Account Saving has also been increased to 7.1% from 6.7%. The interest rate on Kisan Vikas Patra (KVP) will now be 7.2% and will mature in 120 months. The interest rate of a Small Savings Deposit of 1-year time period has been increased to 6.6% from 5.5%. The Interest Rate of 2-year time deposit has changed to 6.8% from 5.7%. However, the interest rate on the Public Provident Fund (PPF) scheme, Sukanya Samriddhi Account Scheme (SSAS) and Saving Deposit have been kept unchanged. The Shyamala Gopinath Committee provided the formula to calculate the interest rates for the small savings scheme. {Read more} The Question Bank
