

On June 29, The centrally sponsored Pradhan Mantri Formalisation of Micro food processing Enterprises (PMFME) Scheme, launched under the Aatmanirbhar Bharat Abhiyan, marked the completion of its one year. The scheme was launched on 29th June 2020 with an outlay of Rs 10,000 Cr over a period of 5 years from 2020-21 to 2024-25. The PMFME Scheme is currently being implemented in 35 States & UTs. 54 Common Incubation Centres have been approved to improve the capacity of the PMFME Scheme. {Read more} **Key Points:**
