Explanations:

1. The sentence is correct in the present form and no correction is required to be carried out in the sentence.

This makes Option E the correct choice among the given options.

2. There is the error in the subject-verb agreement here because the subject here is in singular form whereas the corresponding verb has been used in the plural form i.e. were given. The subject *each* is singular and is followed by singular verbs only. Therefore it should have been *was given*.

The correct sentence would have been:

Each of the boys in the class **was given the task** but none of them could finish the same on time.

This makes Option B the correct choice among the given options.

3. According to the context of the sentence it is regarding the fact that he died and after that his sons inherited the entire business. The correct phrasal verb used for that purpose is *pass away*. Therefore it should have been *he passed away very soon*.

The correct sentence would be:

He passed away very soon after that and his sons took over the entire business.

This makes Option D the correct choice among the given options.

4. Here the context is that due to good monsoon, it is expected that the consumption will be boosted in the rural areas. This is going to be a good sign for the Indian economy. Both I and II will be correct in this context if placed instead of the bold phrase in the given sentence.

The correct sentence would be:

We have seen that the monsoon has reasonably caught up, which should **boost / give a boost to** agriculture and lead to the revival to some extent of consumption in rural India.

This makes Option C the correct choice among the given options.

5. There is no error in the highlighted part of the given sentence and therefore no replacement is required here.

This makes Option E the correct choice among the given options.

6. There is an error in the highlighted part of the sentence for the fact that the subject-verb agreement is not correct here. *There is a lot of under insurance* would have been correct. It is there in the Option I whereas the rest cannot replace the given phrase in bold in the statement.

This makes Option B the correct choice among the given options.

7. There is no error in the highlighted part of the sentence and therefore no correction is required from the given phrases in this case.

This makes Option E the correct choice among the given options.

8. According to the given context, it is regarding the fact that you may get a call asking for your details pertaining to account details with regard to help you claim your windfall gains. The fraudsters also make a lot of excuses like they need the information to keep the account active or verify the details as part of the regulatory procedure. All the given phrases will be correct in the context of the sentence and all of them can be placed in the sentence. Actually the bold part in the sentence has an error because *information* can only be singular in number and the following verb should also be in singular number.

This makes Option E the correct choice among the given options.

9. The context of the sentence is regarding the fact that the company presented an EoI that had the condition that it would reinvest as a minority partner but ultimately the whole thing did not materialize at the end. There is an error in the bold part here for the fact that we have to use an adjective before a noun to modify the same but here we have used an adverb. That is not correct. All the given phrases in the options will fit in the given sentence.

This makes Option E the correct choice among the given options.

10. The given phrase in bold is erroneous as 'rules' are 'made' and not 'declared'.

In the context given, it's implied that some order has been passed by the government with reference to the trains' movement in between states.

Clearly either I or III replaces the bold part most appropriately.

The correct sentence would be:

According to an order issued / As per the instructions laid out the railway zones have been asked to provide three stoppages in the destination State other than the final stop.

Option B is hence the correct answer..
