Explanations:

1. *Ensue* means *result/proceed* and does not fit in. This does not make sense in the statement.

Excess means surplus which is opposite of what is needed.

Ensures is incorrect as it leads to subject verb disagreement.

Accessibility is correct and means ease of access.

The phrase 'ensure accessibility' is correct and fits in well meaningfully and grammatically.

Hence, option A is correct.

2. The correct phrase is around/round the corner.

Around the corner: Nearby, close by, not far away.

Thus, the correct answer is option C.

3. We need the adverb form of 'history'. Thus, 'historically' is correct while 'historic' is incorrect. This eliminates option A.

Being is incorrect as it is used to refer to an individual/person. *Been* is correct here. This eliminates option C.

Due to article 'a', the correct form is 'place' in singular.

Hence, option B is correct.

4. The statement talks about multiple people and thus 'are' is correct.


One is entitled 'to' something and not 'for'. This eliminates option B.

Option C is incorrect as 'a rights' is incorrect grammatically.

Option D is correct grammatically and contextually.

Hence, option D is correct.

Hence, option E is correct.



6. The original sentence is incorrect.

Reason: The bold part lacks parallelism. To bring parallelism the infinitive 'to restore' has to be replaced by the gerund 'restoring' here.

Secondly, as 'Preserving and restoring forests' is implying 'one' idea, the verb to be used has to be singular in number. Therefore, 'are' should be replaced by 'is' to make the sentence correct.

Clearly, among the given choices, option B replaces the bold part most appropriately.

The correct sentence will therefore be:

Preserving and restoring forests is an effective step toward mitigating climate change, and comes with a host of other benefits.

Option B is hence the correct answer.

7. The original sentence is incorrect.

Reason: Here, usage of the preposition 'for' is erroneous. Instead of it, 'of' should be used as the preposition 'of' is followed by a noun expressing the object of the verb underlying the first noun.

Secondly, the preposition 'on' should be replaced by 'at' as we use 'at' while referring to 'rates' in general.

Next, usage of the adverb 'severely' is also ungrammatical. Here, the adjective 'severe' must be used in place of 'severely' as the word before the noun 'rate' has to be an adjective and not an adverb.

Clearly, among the given choices, option C replaces the bold part most appropriately.

The correct sentence therefore will be:

A new scientific report finds human behaviors are driving the extinction of non-human species at a severe rate.

Option C is hence the correct answer.

8. Reason: Here, the sentence implies that the world's population is expected to reach 9.6 billion by the end of 2050 and not 'in' 2050. Therefore, the preposition 'in' should be replaced by 'by'.

Ex. I've got to do this report by Monday.

Secondly, the past participle 'continued', which is acting as an adjective here, should be followed by a noun and not by an infinitive here.

Besides, usage of preposition 'of' right after the noun 'demand' is not appropriate either. Instead of it, 'for' should be used.

Evidently, among the given choices, option D replaces the bold part most appropriately.

The correct sentence will therefore be:

With the world's population expected to reach 9.6 billion **by 2050 and continued growth in demand for meat**, the livestock sector is facing renewed pressure to provide the nutrition to feed that many mouths—sustainably.

Option D is hence the correct answer.

9. The original sentence is incorrect.

Reason: As we can observe that the sentence nowhere implies context of a perfect tense and therefore the verb 'has been' should be replaced by 'is' here.

Secondly, the word 'rhetoric' which means 'language designed to have a persuasive or impressive effect' doesn't seem to go well with the context of the sentence. This eliminates options A and C immediately.

'Retrograde' means 'reverting to an earlier and inferior condition' does make sense in the sentence and therefore must replace the given adjective 'responsive' in the bold part.

Usage of the adjective 'transparent' in the bold phrase is also ungrammatical. It should be replaced by the adverb 'transparently'.

Besides, usage of the preposition 'in' right before the noun 'intent' is absolutely correct.

Evidently, option D replaces the bold part most appropriately.

The correct sentence will therefore be:

The Bar Council of Delhi's directive to the Big Four accountancy firms not to offer legal services to their clients in India is a retrograde move that is transparently protectionist in intent.

Option D is hence the correct answer.

10. The original sentence is incorrect.

Reason: In the bold part, placement of the phrase 'against the Chief Justice of India' is wrong. It should be immediately followed by the noun 'allegations'.

Secondly, the noun 'finding' which implies 'something that is found' is used in its plural case in general. Therefore, 'findings' will be more suitable here.

Clearly, among the available choices, option C replaces the bold part most appropriately.

The correct sentence will therefore be:

An ad hoc committee, following an informal procedure, has concluded that the **allegations against the Chief Justice of India have no substance, but the findings** will not be made public.

Option C is hence the correct answer.
