Common explanations :

The subject that is being discussed in the passage is the listing of Saudi Aramco and the role of United Kingdom's Financial Conduct Authority (FCA).

While solving jumbled sentences puzzle, we understand that the statement which gives an overview and not some specific information comes in the beginning in a passage. Therefore sentence "D", which mentions the anticipated listing of the Saudi Aramco, will be the first. Sentence "D" mentions that the stock exchanges are in pressure; while sentence "F" mentions that the Financial Conduct Authority is bowing to that pressure. Therefore Sentence "F" follows sentence "D".

Linking "F" to "A"

The topic of public listing of Saudi Aramco's is mentioned in sentence "D". Sentence "A" explains this topic further by talking about a proposal for listing on the London Stock Exchange.

Linking "A" to "E"

The mention of a proposal in sentence "A" is continued in sentence "E".

Linking "E" to "B"

Sentence "E" mentions that state-owned enterprises (SOEs) deserve special regulatory treatment. State-owned enterprises are also controlled by the sovereign nation.

Sentence "B" also mentions sovereign owners (...that sovereign owners tend to be different from private-sector individuals...). Thus, E must be followed by B.

Linking "B" to "C"

Sentence "B" says - sovereign owners tend to be different from private-sector individuals. Here the phrase "tend" is used to describe an assumption about sovereign owners by FCA.

Sentence "C" mentions assumption in it, therefore, "B" must be followed by "C".

The correct sequence is DFAEBC.
